

2025 Truterra® Registered Carbon Program with Indigo

EXPANDING PROGRAM OPPORTUNITIES FOR THE TRUTERRA NETWORK

The **2025 Truterra® registered carbon program with Indigo** is part of the Indigo Ag, Inc. registry-certified carbon project and may provide financial incentives for carbon benefits generated by eligible farmers implementing new regenerative practices for the first time. Through a strategic collaboration with Indigo, this program's eligible geographies and crop types may create expanded opportunities for farmers to engage through a Truterra-supported experience.

Eligible farmers will experience the hands-on support available through Truterra and Truterra network providers while potentially generating registry-certified credits from Indigo's carbon project. As a potential benefit of this program, Truterra may pay eligible farmers in two stages, with an advance payment potentially coming after credit issuance and prior to the completion of credit sale. Once contracted, eligible fields will be committed to a minimum of 5 years of practice maintenance and data reporting following the contracted year. *See payments and contracting section below.*

EXCLUSIVITY (DUAL ENROLLMENT)	Disclosure of publicly funded conservation program participation is required for carbon credit verification. Responses are unlikely to affect eligibility. Fields may not be enrolled in another privately funded or incompatible program during the contracting period.

¹Total payment is dependent on several factors, including the project-level average credit selling price.

²Project-level average credit selling price will be determined after credits associated with this project are sold. A weighted average will be used.

³Advance payment is at Truterra discretion, subject to change, and not guaranteed. See FAQ document (https://bit.ly/25TRCI_FAQ) for more information. If Truterra makes a payment of the Advanced Amount, Truterra's final payment to the farmer will be the difference between the sum of 55% of the Average Selling Price and the Advanced Amount if positive.

A small portion of enrolled farmers may also be selected for soil sampling and/or verification.
Eligibility requirements are subject to change based on changes to the requirements of Indigo's registry-certified carbon project.

FILING DEADLINE	January 21, 2026
ESTIMATED PAYMENT TIMELINE	Payment(s) are anticipated to be made in 2027-2028, depending on timeline of project credit issuance and sale

DATA REQUIREMENTS

DATA COLLECTION YEARS	Crop plan data metric for the current year (2025) plus 4 historical crop years (2020-2024)
DATA COLLECTION DEADLINE	September 18, 2025 ⁴

⁴Anticipated harvest information for CY2025 will be requested prior to the stated deadline.
